PLANNING AND ZONING

Mr. George Leary, Land Use Administrator, and Mr. Michael Schulte, Land Use

Specialist, presented the following item to the Board.

Commissioner Stuehrenberg moved and Commissioner Bruender seconded the motion to approve the following resolution:

RESOLUTION GRANTING A REQUEST TO CONSTRUCT ONE TOTAL CONFINEMENT SWINE FINISHING BARN CAPABLE OF HOLDING 2,000 FINISHING SWINE OR 800 ANIMAL UNITS. SAID REQUEST WILL INCREASE THE TOTAL ANIMAL UNITS FOR THE SITE TO 2,120. THE SITE IS LOCATED IN THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 13, MAPLETON TOWNSHIP.

WHEREAS, Melvin Moore Family Trust and Marian Moore, owners of the following real estate in the County of Blue Earth, Minnesota, to wit:

The North Half (N½) of the Southeast Quarter (SE¼) of Section 13, Township 105 North, Range 26 West, Blue Earth County, Minnesota, excepting therefrom the following:

- 1. The North 575' of the West 533' of the Northwest Quarter (NW¼) of the Southeast Quarter (SE¼) of Section 13, Township 105 North, Range 26 West.
- 2. That part of the Northwest Quarter of the Southeast Quarter of Section 13, Township 105 North Range 26 West, Blue Earth County, Minnesota, described as:

 Commencing at an iron pip monument designating the East Quarter corner of Section 13; thence North 89 degrees 11 minutes and 56 seconds West, (assumed bearing), along the East-West center line of Section 13, a distance of 1507.97 feet to the point of beginning; thence continuing North 89 degrees 11 minutes and 56 seconds West, along said East-West center line, 610.00 feet to the northeast corner of a parcel described as the North 575 feet of the West 533 feet of the Northwest Quarter of the Southeast Quarter of said Section 13; then South 00 degrees 15 minutes and 24 seconds West, along the East line of said parcel a distance 575.02 feet to the southeast corner of said parcel; thence South 89 degrees 11 minutes and 56 seconds East, 610.00 feet; thence North 00 degrees 15 minutes and 24 seconds East, 575.02 feet to the point of beginning. Said parcel contains 8.05 acres.

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC 18-13), a copy of said report has been presented to the Planning Commission; and,

WHEREAS; the Planning Commission of the County on the 4th Day of September, 2013, following proper notice held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to forward the matter

to the County Board with a recommendation for approval subject to conditions contained in staff report PC 18-13, and,

WHEREAS; the County Board on the 10th day of September, 2013, held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to approve the request subject to conditions included in staff report PC 18-13, and,

WHEREAS, the Blue Earth County Board of Commissioners finds:

- 1. That the proposed use conforms with the county land use plan.
- 2. The demonstrated need for the proposed use.
- 3. That the proposed use will not degrade the water quality of the county.
- 4. That the proposed use will not adversely increase the quantity of water runoff.
- 5. That soil conditions are adequate to accommodate the proposed use.
- 6. That the proposed use does not create a potential pollution hazard.
- 7. That adequate utilities, access roads, drainage and other necessary facilities have been or are being provided.
- 8. That adequate measures have been or will be taken to provide sufficient off-street parking and loading space to serve the proposed use.
- 9. That facilities are provided to eliminate any traffic congestion or traffic hazard which may result from the proposed use.
- 10. That the conditional use will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted.
- 11. That the establishment of the conditional use will not impede the normal and orderly development and improvement of surrounding vacant property for predominant uses in the area.
- 12. That adequate measures have been or will be taken to prevent or control offensive odor, fumes, dust, noise and vibration, so that none of these will constitute a nuisance, and to control lighted signs and other lights in such a manner that no disturbance to neighboring properties will result.
- 13. That site specific conditions and such other conditions are established as required for the protection of the public's health, safety, morals and general welfare.

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the request for a conditional use permit to construct one total confinement swine finishing barn capable of holding 2,000 finishing swine or 800 Animal Units, increasing the total animal units for the site to 2,120, is **granted** with the following conditions:

- 1. That the total confinement barn conforms to the site plan attached to this report PC 18-13.
- 2. That the feedlot be located on a single, legally described parcel consisting of a minimum of 40 contiguous acres. The parcel shall be a parcel of record, properly recorded in the Blue Earth County Taxpayer Services Office.
- **3.** That the applicant must amend their existing Blue Earth County Feedlot Permit before any animals are placed in the proposed barn.
- 4. That the applicant obtains a Blue Earth County Construction Permit before building begins and within one (1) year from the date the County Board of Commissioners approves the Conditional Use Permit. The permit shall be rendered invalid if application for a Construction Permit is not made within this one (1) year period. Time extensions for Conditional Use Permits must be obtained from the County Board of Commissioners subsequent to a public hearing conducted by the Planning Commission.
- 5. If required by the Department of Natural Resources, the applicant shall obtain a DNR "Water Appropriations Permit" before any animals are placed in the barn.
- That a perimeter footing drain tile be located at or below the bottom of the pit footings. The footing tile shall include one inspection pipe for each concrete pit. The native materials must be excavated and walls back filled with granular material (pit run gravel or equivalent). Exceptions to this may only include specific design standards submitted by the design engineer of the manure storage structure.
- 7. The application of manure shall comply with standards set forth by the MPCA and the County. The applicants manure management plan must be reviewed by the operator each year and updated each year and adjusted for any changes in the amount of manure production, manure nutrient test results and transfer of manure ownership. Records of manure transfer shall be maintained as required by the MPCA. Manure application setback standards for the fields on which the manure is applied shall be followed as required by the MPCA and the County.
- **8.** That the disposal of livestock mortality be consistent with the Minnesota Board of Animal Health regulations, and when rendering is used as a mortality disposal the applicant shall provide an enclosed location for the pick-up.
- **10.** That adequate measures be taken to minimize or control offensive odor, fumes, dust, noise, or vibrations so that none of these will constitute a nuisance.
- 11. That all manure storage structures must be designed by a registered engineer.

- 12. That the applicant will furnish the final construction report to the County Environmental Services verifying that the concrete manure storage structure was constructed per approved engineered design plan within 60 days of completion of any new or modified manure storage area. Said construction report shall be signed by the design engineer.
- 13. That the applicant complies with the storm-water control requirements established by the MPCA.
- **14.** That MPCA construction BMP's be followed including erosion control measures.
- 15. That all exposed earthen surfaces be seeded into grass or utilized as crop acreage.
- 16. If shower, restroom, culinary and/or laundry facilities are to be included with the proposal, that wastewater handling practices are designed and constructed according to state requirements.
- 17. That the applicant shall obtain an updated NPDES permit from the MPCA prior to commencement of construction activities.

This Conditional Use Permit shall become effective immediately upon its passage and without publication.

Findings of Fact and Order for the Redetermination of Benefits, Pursuant to Minnesota Statutes 103E.351.

WHEREAS, the Blue Earth County Drainage Authority, by motion, ordered a Redetermination of Benefits for County Ditch No. 95 in that the benefits do not reflect present day land values and the benefited area has changed; and

WHEREAS, three viewers were appointed to complete the Redetermination of Benefits; and

WHEREAS, proper notice of a Public Hearing on the Redetermination of Benefits was provided, pursuant to Minnesota Statutes 103E.325; and

WHEREAS, a Public Hearing, pursuant to Minnesota Statutes 103E.335, was held on September 10, 2013; and

WHEREAS, public comment on the Redetermination of Benefits was heard by the Drainage Authority;

WHEREAS, the Blue Earth County Drainage Authority, by motion, ordered a Redetermination of Benefits for County Ditch No. 96 in that the benefits do not reflect present day land values and the benefited area has changed; and

WHEREAS, three viewers were appointed to complete the Redetermination of Benefits; and

WHEREAS, proper notice of a Public Hearing on the Redetermination of Benefits was provided, pursuant to Minnesota Statutes 103E.325; and

FINDINGS AND ORDER OF THE BLUE EARTH COUNTY DRAINAGE AUTHORITY FOR THE FOR THE REPAIR OF COUNTY DITCH 95

WHEREAS, the Blue Earth County Drainage Authority determined from the engineers report and from testimony presented that the repairs recommended are necessary for the best interests of the affected property owners.

NOW, THEREFORE, the Blue Earth County Drainage Authority orders the repair of County Ditch 95 and orders I & S Engineers advertise for bids for the repair of County Ditch 95.

Commissioner Piepho moved and Commissioner Bruender seconded the motion to approve the following resolution:

RESOLUTION RELATING TO FINANCING OF CERTAIN PROPOSED PROJECTS TO BE UNDERTAKEN BY THE COUNTY; ESTABLISHING COMPLIANCE WITH REIMBURSEMENT BOND REGULATIONS UNDER THE INTERNAL REVENUE CODE

BE IT RESOLVED by the Board of County Commissioners (the "Board") of Blue Earth County, Minnesota (the "County"), as follows:

1. Recitals.

- (a) The Internal Revenue Service has issued Section 1.150-2 of the Income Tax Regulations (the "Regulations") dealing with the issuance of bonds, all or a portion of the proceeds of which are to be used to reimburse the County for project expenditures made by the County prior to the date of issuance.
- (b) The Regulations generally require that the County make a declaration of its official intent to reimburse itself for such prior expenditures out of the proceeds of a subsequently issued series of bonds within 60 days after payment of the expenditures, that the bonds be issued and the reimbursement allocation be made from the proceeds of such bonds within the reimbursement period (as defined in the Regulations), and that the expenditures reimbursed be capital expenditures or costs of issuance of the bonds.

(c) The County desires to comply with requirements of the Regulations with respect to certain projects hereinafter identified.

2. <u>Official Intent Declaration</u>.

(a) The County proposes to undertake the following project or projects and to make original expenditures with respect thereto prior to the issuance of reimbursement bonds, and reasonably expects to issue reimbursement bonds for such project or projects in the maximum principal amounts shown below:

<u>Project</u> CD 95 REPAIRS Maximum Amount of Bonds <u>Expected to be Issued for Project</u> \$550,000.00

(b) Other than (i) de minimis amounts permitted to be reimbursed pursuant to Section 1.150-2(f)(1) of the Regulations or (ii) expenditures constituting preliminary expenditures as defined in Section 1.150-2(f)(2) of the Regulations, the County will not seek reimbursement for any original expenditures with respect to the foregoing projects paid more than 60 days prior to the date of adoption of this resolution. All original expenditures for which reimbursement is sought will be capital expenditures or costs of issuance of the reimbursement bonds.

3. <u>Budgetary Matters</u>.

As of the date hereof, there are no County funds reserved, pledged, allocated on a long term basis or otherwise set aside (or reasonably expected to be reserved, pledged, allocated on a long term basis or otherwise set aside) to provide permanent financing for the original expenditures related to the projects, other than pursuant to the issuance of the reimbursement bonds. Consequently, it is not expected that the issuance of the reimbursement bonds will result in the creation of any replacement proceeds.

4. Reimbursement Allocations.

The County's Financial officer shall be responsible for making the "reimbursement allocations" described in the Regulations, being generally the transfer of the appropriate amount of proceeds of the reimbursement bonds to reimburse the source of temporary financing used by the County to make payment of the original expenditures relating to the projects. Each reimbursement allocation shall be made within 30 days of the date of issuance of the reimbursement bonds, shall be evidenced by an entry on the official books and records of the county maintained for the reimbursement bonds and shall specifically identify the original expenditures being reimbursed.

Commissioner Bruender moved and Commissioner Piepho seconded the motion to amend the abovementioned motion from \$400,000.00 to \$550,000.00. The motion carried. 2013-276

- (a) The Internal Revenue Service has issued Section 1.150-2 of the Income Tax Regulations (the "Regulations") dealing with the issuance of bonds, all or a portion of the proceeds of which are to be used to reimburse the County for project expenditures made by the County prior to the date of issuance.

(b) Other than (i) de minimis amounts permitted to be reimbursed pursuant to Section 1.150-2(f)(1) of the Regulations or (ii) expenditures constituting preliminary expenditures as defined in Section 1.150-2(f)(2) of the Regulations, the County will not seek reimbursement for any original expenditures with respect to the foregoing projects paid more than 60 days prior to the date of adoption of this resolution. All original expenditures for which reimbursement is sought will be capital expenditures or costs of issuance of the reimbursement bonds.

3. Budgetary Matters.

As of the date hereof, there are no County funds reserved, pledged, allocated on a long term basis or otherwise set aside (or reasonably expected to be reserved, pledged, allocated on a long term basis or otherwise set aside) to provide permanent financing for the original expenditures related to the projects, other than pursuant to the issuance of the reimbursement bonds. Consequently, it is not expected that the issuance of the reimbursement bonds will result in the creation of any replacement proceeds.

4. Reimbursement Allocations.

The County's Financial officer shall be responsible for making the "reimbursement allocations" described in the Regulations, being generally the transfer of the appropriate amount of proceeds of the reimbursement bonds to reimburse the source of temporary financing used by the County to make payment

of the original expenditures relating to the projects. Each reimbursement allocation shall be made within 30 days of the date of issuance of the reimbursement bonds, shall be evidenced by an entry on the official books and records of the county maintained for the reimbursement bonds and shall specifically identify the original expenditures being reimbursed.
