- Northern States Power Company requires ash disposal services through the current fuel contract and would like to defer entering into any long term ash disposal services contract until a new fuel contract is secured.

B. AMENDMENT TO CONTRACT AGREEMENT

Therefore, Northern States Power Company and Blue Earth County mutually agree to extend the existing contract Agreement with all its provisions, terms and rights to each of the parties unchanged through December 31, 2012.
